One of ADAP's priority issues is to ensure that individuals with disabilities have meaningful access to integrated employment and are paid at least minimum wage. We have a long way to go: as of 2013, only Hawaii (2%) had a lower rate of state Intellectual Disability (ID) clients working in integrated settings than Alabama (4%).



Angie Allen, ADAP Case Advocate, attended the Birmingham event and had this to say: "When I became disabled at age twenty six, the ADA had not been created, so I had no legal rights to enforce if I had a problem with an employer or with a business that had no access for wheelchairs. Now there is, thanks to the ADA. This day has been a great reminder of where we have come from and for a hope that there can be fuller implementation of the law in the future."
