# State Legislature Grappling Again with Budget Shortfalls



Given the significant General Fund budget shortfall, funding the state's FY17 operations is going to be a hot issue for the Alabama legislature when it reconvenes on February 2. In preparation for the upcoming regular session, budget hearings were held on January 12 and 13. During these hearings, Commissioners of the Alabama Medicaid Agency and the Departments of Corrections, Mental

Health, Human Resources, and Senior Services – all agencies which provide significant services to persons with disabilities – answered difficult questions about their Departments' budget proposals. To read more, click here.

By exercising your right to vote, you have the amazing opportunity to select our elected officials and voice your support of or opposition to state and local ballot questions. One important voting deadline is quickly approaching: to vote in Alabama's primary election on March 1, 2016, you must register to vote by February 12 (hand-

delivery of registration) or February 13 (postmark on registration form). Check out the 2016 Alabama Voter's Guide to learn more about voting eligibility requirements and procedures.
